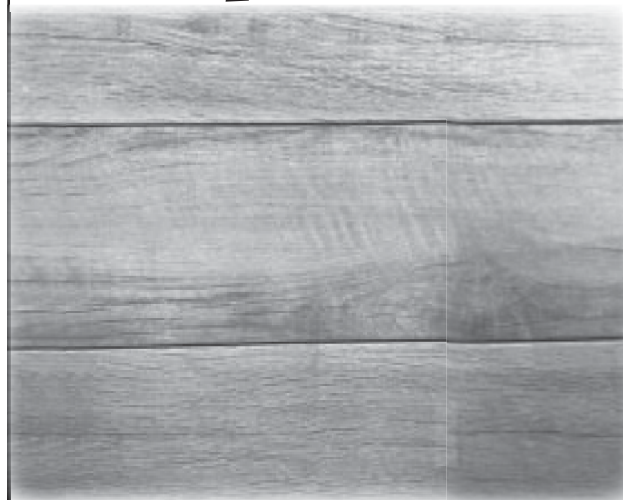

The engineering services required may include planning, design, and/or construction oversight of the project. Facility plans and engineering reports should adhere to 10 CSR 20-8.110 Engineering – Reports, Plans, and Specifications. Funding for the project is through the Missouri Department of Natural Resources' Financial Assistance Center.

A. The specialized experience and technical competence of the firm with respect to the type of services required (10 points);
