There were 52 cases on the docket for Judge Craig Carter back on May 13.

Rachael Conrad, 43, of Springfield, received five years probation for non-support, total arrears in excess of 12 monthly payments due under order of support.

Robert Reed, 46, of Mountain Grove, received four years in the Department of Corrections (DOC) for failure to register as a sex offender.

Aaron Price, 40, of Man-

sfield, received four years in the DOC for unlawful use of a weapon (exhibiting).

Joseph Walker, 31, of Muskegon, Mich., received five years supervised probation for tampering with a motor vehicle in the first degree.

Larry Parrish, 34, of Grovespring, received two years in the DOC for failure to register as a sex offender.

Andrew Witt, 44, of Mountain Grove, received five years super-

vised probation for possession of a controlled substance.

Clinton Ward, 54, of Hartville, received two years supervised probation for second degree harassment.

Michael Tippetts, 41, of Mountain Grove, received 15 days in county jail for fourth degree domestic assault (first or second offense).

Nathan Tomlinson, 39, of Nixa, received four years in the DOC for DWI-persistent.
